Fee can either be deposited through challan to be generated on line after filling up the on-line application form and cash deposited in any branch of prescribed Banks all over India OR other option is to use e-banking/debit/credit card for on-line payment option available while completing the form in which case the candidates is not required to send the challan copy, while sending the form
